### 1. Introduction and General Terms

Brasenose Ball 2017 is committed to protecting your personal information when you are using Brasenose Ball 2017's services. For information about our use of personal information you provide through other sources (such as information collected at the Ball itself), please consult our general Terms and Conditions on our website.

This privacy policy explains the following:

- what information Brasenose Ball 2017 may collect about you through its website;
- how Brasenose Ball 2017 will use information we collect in this way;
- whether Brasenose Ball 2017 will disclose your details to anyone else;
- your choices regarding the personal information you have provided to us;
- the use of cookies on Brasenose Ball 2017's website and how you can reject these cookies.

As set out above, Brasenose Ball 2017 is committed to safeguarding your personal information supplied on its website. Whenever you provide such information, we are legally obliged to use your information in line with all laws concerning the protection of personal information, including the Data Protection Act 1998 (these laws are referred to collectively in this Privacy Policy as the "data protection laws").

The website contains hyperlinks to websites owned and operated by third parties. These third party websites have their own privacy policies, including cookies, and we urge you to review them. They will govern the use of personal information you submit or are collected by cookies whilst visiting these websites. We do not accept any responsibility or liability for the privacy practices of such third party websites and your use of such websites is at your own risk.

## **2. What information will Brasenose Ball 2017 collect about me?**

We will ask for personal information about you, such as your name, email address, postal address, and telephone or mobile number.

By entering your details in the fields requested, you enable the Brasenose Ball 2017 to provide you with tickets to the Ball.

Brasenose Ball 2017 also uses cookies and collects IP addresses (an IP address is a number that can uniquely identify a specific computer or other network device on the internet). We use analysis software to look at IP addresses and cookies for the purpose of enhancing your user experience. This information is not used to develop a personal profile of you and the log files are regularly purged.

## **3. How will Brasenose Ball 2017 use the information they collect about me?**

Brasenose Ball 2017 will use the personal information you submit on its website for the purpose of organising the Ball.

Where Brasenose Ball 2017 proposes using this personal information for any other uses we will ensure that we notify you first. You will also be given the opportunity to withhold or withdraw your consent for your use other than as listed above.

## **4. When will Brasenose Ball 2017 contact me?**

Brasenose Ball 2017 will contact you:

- to confirm purchase of Ball tickets;
- to supply further information about the Ball.

## **5. Will I be contacted for marketing purposes?**

Brasenose Ball 2017 will not contact you for marketing purposes, or promote new services to you unless you specifically agree to be contacted for these purposes.

## **6. Will Brasenose Ball 2017 share my personal information with anyone else?**

We will keep your information confidential except where disclosure is required or permitted by law (for example to government bodies and law enforcement agencies).
